WE HELP WORKPLACES ORGANIZE GREEN TEAMS, TEACH THEM ABOUT SUSTAINABILITY, AND CONNECT THEM TO COMMUNITY RESOURCES THAT MAKE A DIFFERENCE FOR THEIR BUSINESS THROUGH THE NASHVILLE SUSTAINABILITY ROUNDTABLE, SUSTAINABILITY DIRECTORY AND B TENNESSEE. IN 2025, OUR WORKPLACES DIVISION PRIORITIZED OPPORTUNITIES FOR EDUCATION AND COMMUNITY BUILDING. WE HOSTED IN-PERSON EVENTS, SUCH AS ROUNDTABLES, FOR ORGANIZATIONS LOOKING TO FOSTER A CULTURE OF SUSTAINABILITY IN THEIR WORKPLACES, AND SPOKE ON MULTIPLE PANELS ABOUT SUSTAINABLE BUSINESS. WE ALSO LAUNCHED THE SUSTAINABLE NASHVILLE DIRECTORY FEATURING BUSINESSES THAT BALANCE PROFIT WITH CARE FOR THE PLANET. IN 2025, THE WORKPLACES DIVISION ENGAGED 42 ORGANIZATIONS. PARTICIPATING BUSINESSES GAINED ACCESS TO B TENNESSEE CERTIFICATION SUPPORT, PEER TO PEER LEARNING OPPORTUNITIES, AND THE NASHVILLE SUSTAINABILITY ROUNDTABLE NETWORK.

OUR PROGRAMMING TOUCHES ON MANY OF THEM. HOWEVER, WE BELIEVE IT'S ESSENTIAL TO HIGHLIGHT AREAS WHERE RESIDENTS CAN MAKE A SIGNIFICANT POSITIVE IMPACT AND TO RAISE AWARENESS OF THE DAILY DECISIONS THAT AFFECT OUR NEIGHBORS AND THE PLANET. AS PART OF OUR SPECIAL INITIATIVES, URBAN GREEN LAB LAUNCHED SEVERAL INNOVATIVE PROJECTS TO ADVANCE SUSTAINABILITY EDUCATION ACROSS MIDDLE TENNESSEE. NOTABLY, OUR VOICES OF RESILIENCE ORAL HISTORY PROJECT HIGHLIGHTED FRONTLINE CLIMATE EXPERIENCES IN UNDERSERVED COMMUNITIES. THE WASTE LESSTM MURAL SERIES CREATIVELY RAISES AWARENESS ABOUT FOOD WASTE THROUGH PUBLIC ART. ADDITIONALLY, WE CONVENED THE NASHVILLE SUSTAINABLE SPORTS ALLIANCE, UNITING PROFESSIONAL SPORTS TEAMS TO PROMOTE

THE PROGRAM EQUIPS VOLUNTEERS WITH THE KNOWLEDGE AND CONFIDENCE TO FACILITATE MEANINGFUL CONVERSATIONS ON SUSTAINABILITY. IN 2025, SUSTAINABLE IN THE CITY PODCAST SERIES CONCLUDED WITH FOUR FINAL EPISODES REACHING 120 PARTICIPANTS. THE UGL VOLUNTEERS PROGRAM TRAINED 45 MORE NASHVILLIANS AS SUSTAINABILITY AMBASSADORS. TOPICS COVERED INCLUDED POLLINATORS, CURBSIDE COMPOSTING, AND FOOD WASTE REDUCTION.

BOTH GRANTS WERE ADMINISTERED THROUGH FEDERAL AGENCIES THAT UNDERWENT SUBSTANTIAL RESTRUCTURING DURING THIS PERIOD. THESE RESCISSIONS WERE BEYOND THE ORGANIZATION'S CONTROL AND REFLECT A CHALLENGE THAT AFFECTED NONPROFITS NATIONWIDE DURING THIS TIME. IN RESPONSE, URBAN GREEN LAB'S LEADERSHIP AND BOARD ACTED SWIFTLY AND DECISIVELY. THE ORGANIZATION REDUCED ITS APPROVED OPERATING BUDGET BY MORE THAN 40 PERCENT, FROM \$1,100,000 TO APPROXIMATELY \$635,000, RESTRUCTURED ITS STAFFING MODEL, AND IMPLEMENTED COST CONTROLS THAT ALLOWED IT TO HONOR ALL EXISTING PROGRAMMATIC COMMITMENTS TO COMMUNITY PARTNERS AND PROGRAM PARTICIPANTS WITHOUT INTERRUPTION. URBAN GREEN LAB MET ALL FINANCIAL OBLIGATIONS THROUGHOUT THE YEAR. DESPITE THESE HEADWINDS, THE ORGANIZATION MAINTAINED THE FULL SCOPE OF ITS PROGRAMMING ACROSS ITS WORKPLACES, HOUSEHOLDS, AND SPECIAL INITIATIVES DIVISIONS. IN PARALLEL, UGL COMPLETED A NEW MULTI-YEAR STRATEGIC PLAN AND LAUNCHED A NEW FUNDRAISING EVENT TO BEGIN DIVERSIFYING REVENUE AWAY FROM FEDERAL SOURCES. THE 2025 OPERATING DEFICIT OF \$82,812 REFLECTS AN ORGANIZATION THAT ABSORBED A REVENUE LOSS MANY TIMES LARGER THAN THE RESULTING DEFICIT, DEMONSTRATING THE RESILIENCE AND FISCAL DISCIPLINE OF BOTH STAFF AND BOARD LEADERSHIP. IT IS ALSO WORTH NOTING THAT THE 2025 OPERATING DEFICIT OF \$82,812 INCLUDES \$9,977 IN NON-CASH DEPRECIATION EXPENSE, RESULTING IN AN ACTUAL CASH DEFICIT OF APPROXIMATELY \$72,835. THE ORGANIZATION ENDED THE YEAR WITH POSITIVE NET ASSETS OF \$248,910. THE BOARD FINANCE COMMITTEE HAS APPROVED A 2026 OPERATING BUDGET DESIGNED TO RETURN TO OPERATIONAL BALANCE THROUGH CONTINUED EXPENSE DISCIPLINE AND AN ACCELERATED FOCUS ON DIVERSIFIED REVENUE INCLUDING CORPORATE SPONSORSHIPS, EARNED PROGRAM REVENUE, AND INDIVIDUAL GIVING.
